Pymble Ladies' College Bequests

A bequest is a gift and can be either named or anonymous. It is contained within a will and specifically reserves part of an estate for a particular beneficiary.

Bequests can be made in a variety of ways to reflect a donor's wishes. They can be defined personal assets such as bonds, property, fixed sums or a percentage of an estate.

Bequests are usually directed to Pymble Ladies' College for use at its discretion. Such unencumbered gifts allow the College the flexibility to use donations in areas of particular need.

Alternatively, bequests can be directed to a specific area of Pymble Ladies' College, such as a particular academic discipline (for example, Science); or to a Co-curricular activity (for example, Drama, sport); or to the Pymble Ladies' College Building Fund.

Bequests can also be made to particular funds set up by the College for a specific purpose such as for scholarships or buildings. Funds such as these qualify as deductible gift recipients for tax purposes and carry significant tax benefits over gifts made to other areas of the College or gifts for use at the College's discretion.

HOW TO MAKE A BEQUEST

We recommend that you consult your solicitor before finalising arrangements to ensure that they are appropriate for your personal wishes and circumstances. By informing Pymble Ladies' College about your bequest you allow the College to thank and acknowledge you in your lifetime. By advising Pymble Ladies' College of your intentions, you also ensure that Pymble Ladies' College is able to appropriately fulfil your intended wishes.

All bequest correspondence with Pymble Ladies' College is confidential.

To make a bequest to Pymble Ladies' College you might like to consider the suggested wording opposite. The suggestions may assist your solicitor in the preparation of your will.

If you have already made a will, you may simply add a codicil to include Pymble Ladies' College – a straightforward and inexpensive procedure.

SUGGESTED FORMS OF WORDING

The following clauses are intended simply to guide you should you be considering Pymble Ladies' College when making your will or alterations to it by way of a codicil. It is important that you consult your solicitor who will be able to ensure that the wording is appropriate for the bequest you wish to make and for your particular circumstances.

REMEMBERING THE PAST

Gifts to specific tax deductible funds

Pymble Ladies' College has two tax deductible gift recipient (DGR) funds as follows:

1. Pymble Ladies College Building Fund (ABN 78 619 140 464)

This Fund provides for the acquisition, construction or maintenance of College buildings. By directing your gift to the building fund you ensure that Pymble Ladies' College is able to maintain its development for the benefit of future generations of Pymble girls.

2. Pymble Ladies' College Scholarship Fund (ABN 78 619 140 464)

This Fund provides money for scholarships to enable deserving young girls, from diverse backgrounds, the opportunity to attend Pymble Ladies' College.

INVESTING IN THE FUTURE

Gifts to one or more of these funds can only be used specifically for the purpose of the Fund to which they are bequeathed. A bequest made in this way is exempt from Capital Gains Tax and can also receive other tax concessions.
