
CHIX SURF SCHOOL AND DEVELOPMENT PROGRAM



SAFE SURFING PROGRAM DECLARATION

RISK WARNING AND WAIVER

In consideration of Chix Surf School and Development Program ('Chix Surf School ') accepting my application to participate in the Program, below I acknowledge, understand and agree that:

- 1. Warning: Participating in the lessons and programs provided by Chix Surf School ('the Program') can be inherently dangerous. I acknowledge that I am exposed to certain risks during the Program including but not limited to physical hazards, unpredictable and sometimes dangerous surf and weather conditions and actions of other people and things in and near the water. I acknowledge that accidents can and often do happen which may result in me being injured or even killed, or my property being damaged. I have voluntarily read and understood this warning and accept and assume the inherent risks in participating in the Program.
- 2. Physical Fitness: I must not participate in the Program if I have any injury, disability, medical or health condition that may increase the risk of me becoming injured unless I have told Chix Surf School about it and they have authorised me to participate. I declare that I am medically and physically fit and able to participate in the Program and I will immediately notify Chix Surf School of any change to my fitness and ability to participate.
- 3. **Instructions:** I will **at all times** comply with the instructions and safety procedures of Chix Surf School.
- 4. Medical Treatment: If required, Chix Surf School will arrange medical or hospital treatment (including ambulance transportation) for me. I authorise such actions being taken by Chix Surf School and agree to meet all costs associated with such action.
- 5. Exclusion of Implied Terms: I acknowledge that where I am a consumer of recreational services, as defined by any relevant law, certain terms and rights usually implied into a contract for the supply of goods or services may be excluded. I acknowledge that these implied terms and rights and any liability of Chix Surf School (or any of its agents and employees) flowing from them, are expressly excluded to the extent possible by law, by this declaration. To the extent of any liability arising, the liability of Chix Surf School will (at the discretion of the relevant Organiser) be limited to the resupply of the services or payment of the cost of having the services supplied again.
- 6. Release & Indemnity: My participation in the Program is entirely at my own risk and I agree to the extent permitted by law to:
 - (a) release and forever discharge Chix Surf School from all liability and Claims that I may have or may have had but for this release arising from or in connection with my participation in the Program;
 - (b) indemnify and hold harmless Chix Surf School to the extent permitted by law in respect of any Claim by any person including another participant in the Program arising as a result of or in connection with my participation in the Program.

- In Clause 6 "Claims" means and includes any action, suit, proceeding, claim, demand, damage, cost or expense however arising including but not limited to negligence.
- 7. **Identity:** Photographic and or visual images taken by Chix Surf School of my participation in the Program may be used for general promotion of its activities.
- 8. **Privacy:** I understand that the information provided by me in this form is necessary for the operation of the Program. I acknowledge and agree that the information will only be used for the objects of Chix Surf School and to provide me with information pertaining to the Program. I understand that I will be able to access my information through Chix Surf School upon request. If the information is not provided I might not be permitted to participate in the Program.
- 9. Severance: If any provision of this declaration is invalid or unenforceable in any jurisdiction, the phrase or clause is to be read down for the purpose of that jurisdiction, if possible, so as to be valid and enforceable. If the phrase or clause cannot be so read down it will be severed to the extent of the invalidity or unenforceability. Such severance does not affect the remaining provisions of this declaration or affect the validity or enforceability of it in any other jurisdiction.
